- a. Advocacy Marsetta Ray, Chair
  - i. GA CO-AGE Annual meeting held in Macon, 7/13/23
    - 1. Will present Legislator of the year award and Award for Senior activists
    - 2. To highlight issues for 2024 Georgia Legislative consideration including medical aid in dying
    - 3. COEA has 7 votes and will vote on issues; voting opens after 7/14/23
  - ii. Social Security Administration (SSA) call wait times for disability claims may increase; Committee Chair requested for COEA members to call Congress and voice concerns
  - iii. Senators Kirsten Gillibrand and Lindsey Graham introduced bipartisan legislation Protecting Older

Americans Act. (The legislation would invalidate forced arbitration clauses that prevent age discrimination victims from seeking justice and public accountability.)

- Prohibits forced arbitration and claims in the workplace; Age discrimination is a reality in the workforce; When someone is hired, they are forced into signing the arbitration agreement
- 2. Goal make sure seniors are protected
- iv. Financial exploitation key COEA priority for the year
- V. HR2593 bill passed in the House creation of Security Exchange Commission (SEC) taskforce to identify challenges seniors face while investing and recommended changes to laws; federal study of economic cost of elder abuse – robocalls and voice phishing/swooping
  - 1. COEA members requested to contact legislators to support HR2593
- vi. AARP and Alzheimer's Association hosting Family Caregiver Forum on 7/20/23 11am 1pm
  - 1. Caregivers to share experience and provide resources available to caregivers in Fulton County
- vii. HR7107 monitoring the Long-Term Care Affordability Act
  - Referenced Bob Casey advocate for long-term care
  - 2. HCBS services through GCOA perennial issue
  - Requesting COEA members to get behind efforts; call legislators to support federal movement of long term care support
